Cities for Workforce Health Grant Program

- Cities for Workforce Health is designed to engage League of CA cities and their employees in building a culture of health and making enhanced health and wellness a reality at the workplace.
- Cities for Workforce Health is a program of the League of CA Cities, League Partners Program. It supports CA cities in improving the health of their employees and is made possible in partnership with Kaiser Permanente and Keenan and Associates.
- Apply for the 2024-25 grant program. Up to five California cities will receive oneon-one workforce health consultation and a \$5,000 credit towards wellness programming.







Application Process

- 2025 Grant Application link <u>here</u>
- Application due date: Friday, July 19, 2024
- Five cities will be selected, based on the following criteria:
 - Demonstration that a basic wellness program infrastructure is currently in place (e.g. leadership team or steering committee has been formed; wellness champions have been identified; and/or a survey or assessment of health needs/risks has been conducted)
 - Readiness to initiate or further develop a worksite wellness program
 - Commitment to building the program's infrastructure and capacity
 - Need for professional consultation to assist with program development efforts

Note: Current Cities for Workforce Health grantees (2024) and previous two grant cycles (2022, 2023) are not eligible to apply for the upcoming year. This gives other Cities an opportunity to request support for their workforce health initiatives.
